In consideration of the services of the Oxford Skate Park, Oxford Parks and Recreation Department, City of Oxford, their agents, owners, officers, volunteers, participants, employees, and all other persons or entities acting in any capacity on their behalf (hereinafter collectively referred to as "Oxford Skate Park"), I/We hereby agree to release, indemnify, and discharge the Oxford Skate Park, on behalf of myself, my children, my parents, my heirs, assigns, personal representative and estate as follows:

1. I/We acknowledge that inline skating, and/or skateboarding entails known and unanticipated risks which could result in physical or emotional injury, paralysis, death, or damage to myself, to property, or to third parties. I understand that such risks simply cannot be eliminated without jeopardizing the essential qualities of the activity.  
The risks include among other things: Collision with other participants, the walls, other fixed objects; falling down; my own equipment failure or the failure of other's equipment; my own or others negligence; and objects or conditions on the surface that may cause me to fall; broken bones, sprains, head and back injuries, abrasions, and bruises.
2. I/We expressly agree and promise to accept and assume all of the risks existing in this activity. My participation in this activity is purely voluntary, and I/We elect to participate in spite of the risks.
3. I/We hereby voluntarily release, forever discharge, and agree to indemnify and hold harmless the Oxford Skate Park from any and all claims, demands, or causes of action, which are in any way connected with my participation in this activity or my use of the Oxford Skate Park equipment or facilities, including any such Claims which allege negligent acts or omissions of the Oxford Skate Park.
4. Should Oxford Skate Park or anyone acting on their behalf, be required to incur attorneys fees and costs to enforce this agreement, I/We agree to indemnify and hold them harmless for all such fees and costs.
5. I/We certify that I have adequate insurance to cover any injury or damage I may cause or suffer while participating, or else I agree to bear the costs of such injury or damage myself. I further certify that I have no medical or physical conditions which could interfere with my safety in this activity, or else I am willing to assume and bear the costs of all risks that may be created, directly or indirectly, by any such condition.
6. I/We understand that all rules, regulations, and requirements as set by the City of Oxford, Oxford Parks and Recreation Department shall be enforced at all times and that any violation of these rules, regulations, or requirements shall carry consequences as set by the City of Oxford which may include expulsion from the property. Expulsion from the property includes any presence on the property which shall include observation. Any such presence on the property, or use of the facility during any expulsion period shall be considered as trespassing.
7. I/We agree to enter into a partnership with the Oxford Skate Park to assist in the enforcement of rules, regulations, and requirements. I also agree that I will assist in keeping the Park clean and attractive.

**By signing this document, I acknowledge that if anyone is hurt or property is damaged during my participation in this activity, I may be found by a court of law to have waived my right to maintain a law suit against the Oxford Skate Park on the basis of any claim from which I have released them herein.**

**I have had sufficient opportunity to read this entire document. I have read and understood it, and I agree to be bound by its terms.**

**RULES AND REGULATIONS**

1. Use of the Skate Park facility is prohibited without a permit obtained through the Oxford Parks and Recreation Department. Permits **MUST** be on your person when using the facility.
2. All participants must have a signed and notarized waiver on file with the Oxford Parks and Recreation Department prior to using this facility. All participants under the age of 18 must have a waiver signed by a parent or guardian.
3. All participants must have adequate health insurance in order to obtain a permit to use this facility.
4. All participants must wear required safety equipment. Required equipment includes:
  - a. Helmets (approved for skating)
  - b. Elbow Pads
  - c. Knee Pads
5. No bicycles are allowed in the park.
6. No scooters are allowed in the park
7. No glass containers are allowed in the park.
8. No profanity is allowed on City Property.
9. Only one person on a board at the time.
10. Only one person on an obstacle at the time.
11. No drugs, alcohol, or other illegal substances are allowed on City Property.
12. All participants must be courteous to others. Consideration for novice skaters and boarders must be made.
13. **NO LITTERING.** Please pick up your trash and keep your park clean and beautiful.

**Violations of rules and regulations shall carry the following penalties:**

1. Skating without permit on your person...but have a permit.
  - 1<sup>st</sup> offense – Warning and expulsion for the day.
  - 2<sup>nd</sup> offense- 1 week expulsion
  - 3<sup>rd</sup> offense – 30 day expulsion
  - 4<sup>th</sup> offense – 60 day expulsion
  - More offenses – revocation of permit for 1 year
2. Skating without a permit
  - 1<sup>st</sup> offense – Warning and expulsion until permit is obtained
  - 2<sup>nd</sup> offense – Charge of Trespassing- revocation of permit for 60 days
  - 3<sup>rd</sup> offense - Charge of Trespassing – revocation of permit for 6 months
  - 4<sup>th</sup> offense – Charge of Trespassing – revocation of permit for 12 months
  - More offenses – Charge of Trespassing – permanent revocation of permit
3. Possession of Glass Container on Premises
  - 1<sup>st</sup> offense – Expulsion from park for 6 months
  - 2<sup>nd</sup> offense – Expulsion from park for 12 months
  - 3<sup>rd</sup> offense – Permanent revocation of permit
4. Use of bicycle or scooter in park
  - 1<sup>st</sup> offense – Warning and expulsion for the day
  - 2<sup>nd</sup> offense – 1 week expulsion
  - 3<sup>rd</sup> offense – 30 day expulsion
  - 4<sup>th</sup> offense – 60 day expulsion
  - More offenses – revocation of permit for 1 year
5. Failure to wear required protective gear
  - 1<sup>st</sup> offense – Warning and expulsion 30 days
  - 2<sup>nd</sup> offense – 60 day expulsion
  - 3<sup>rd</sup> offense – 6 month expulsion
  - 4<sup>th</sup> offense – revocation of permit for 1 year
  - More offenses – Permanent revocation of permit
6. Profanity, bullying, failure to obey employees directions
  - 1<sup>st</sup> offense – Warning and expulsion for 1 week

- 2<sup>nd</sup> offense – 30 day expulsion
  - 3<sup>rd</sup> offense – 6 month expulsion
  - 4<sup>th</sup> offense – revocation of permit for 1 year
  - More offenses – Permanent revocation of permit
7. Possession of drugs, alcohol, or other illegal substances shall result in permanent revocation of permit to use the park.
8. Littering
- 1<sup>st</sup> offense – Warning, requirement to “clean the area” prior to being allowed back into the park.
  - 2<sup>nd</sup> offense – 1 week expulsion and requirement to “clean the area”
  - 3<sup>rd</sup> offense – 30 day expulsion and requirement to “clean the area”
  - 4<sup>th</sup> offense – 6 month expulsion and requirement to “clean the area”
  - More offenses – Revocation of permit for one year

STOP!! You MUST have a notarized waiver and permit to use this facility. A waiver may be obtained from the Oxford Parks and Recreation Department or City Hall. All waivers must be notarized. For participants under the age of 18, a parent or guardian must sign the waiver.

YOU MUST HAVE A PERMIT WITH YOU TO USE THIS FACILITY!!! Only a valid permit obtained from the City of Oxford is accepted admittance into this park. A PERMIT may be obtained through the Oxford Parks and Recreation Department.
